#### Position Purpose

A Camp Ocean Pines Health Supervisor will ensure all aspects of camper health and safety; reviewing camper records, performing campers' initial health checks, accepting and administering medications, maintaining health logs during all summer camp sessions and oversee healthcare volunteers.

#### Essential Functions

Must be able to perform the following functions unaided or with the assistance of reasonable accommodation:

Help review all health records before camp sessions, communicating with families when needed.

Help cover health center and medication administration when needed.

Oversee all COVID-19 testing and procedures for staff and campers alongside Summer Camp Director.

Support the intake and outtake of all camper medications on check in and out days.

Administer medications to camper per health histories and doctor orders.

Help maintain all Camp medical logs from medication administration and daily health logs.

Setup and maintain Camp's health center to a high quality of cleanliness.

Order and create Camp first aid kits, including maintaining contents throughout the season.

Create organized system to store medications to protect health of all campers and staff.

Perform health checks for all campers within first day of camp.

Communicate with Summer Camp Director and Director team in emergency situations.

Help lead training about basic healthcare for Camp staff.

Respond to any health concerns around Camp following Camp Health Protocols.

Provide a safe, welcoming space where all campers feel accepted.

Help lead Camp activities that are age appropriate, mission driven and creative.

Serve as a mentor to Camp youth, providing advice and coaching techniques when appropriate.

Be a positive role model to youth and Camp staff in attitude and behavior.

Communicate efficiently with leadership on how to assist yourself and campers.

Maintain proper self-care for self; mental and physical.

#### Other Duties and Responsibilities

Consistently provide friendly courteous assistance, including building and maintaining healthy professional relationships with campers, parents, staff and guests.

Support and contribute to a safe, clean environment for all guests and staff.

Be tech-free while working with campers, only to be used on off-times.
